Meeting called to order by the Town Chairman Linda Jonet at 7:00 PM

Order of Business:

Approval of the May Monthly Meeting notes - motion made by Leonard Wachal, 2nd by Ken Dart to approve. 2 ayes, 0 naves. Motion carried.

Treasurer's Report:

As of 5/31/22 - \$89,469.38 in checking, \$178,480.87 in one Money Market and \$59,644.30 in another Money Market. Personal Property has not been paid for by Scott Weidner Construction. In June we received the Recycling grant of \$1,605.54, \$57.78 for managed forest land and the ARPA funds of \$77,245.39.

Zoning Report:

Edith Lauscher reported we received \$400 from Brad Zellner for a rezoning meeting, \$400 from Jason Altmann for a permit and \$430 from Scott Salentine for a garage and addition to the house.

New Business:

Approval of Liquor licenses for The Rendezvous and Luxemburg Sportsman Club - motion made by Ken Dart, 2nd by Leonard Wachal to approve. 2 ayes, 0 naves. Motion carried.

Casco Sand & Gravel has paid for a mining permit. We have not received a request from Philips Truck yet.

The following people were appointed to the Planning Committee: Jim Salentine-Chair, John Haen, Greg Ronsman, Paul Rank, Gene Seidl and Jerry Miesler-alternate. Motion made to approve by Leonard Wachal, 2nd by Ken Dart to approve. 2 ayes, 0 naves. Motion carried.

Discussed the new revisions to the Ordinance regarding Special Events/Wedding Barns as approved by the Planning Commission. Voting on the Ordinance will take place at the next monthly meeting.

The inspection of property at N7034 County Rd AB by Scott Beining, the Building Inspector recommended it be razed and removed within 60 days.

Received the sign donation by the Joe Thibaudeau family for the Sacred Heart Cemetery in Scarboro.

Motion to approve monthly bills made by Leonard Wachal, 2nd by Ken Dart. 2 ayes, 0 naves. Motion carried.

Linda Jonet shared with the group that the Luxemburg Village TAC meeting stated their 20 year plan was for 150/200 more horses in the village to be built and incorporating land from Seidl and Tremel property up to $\frac{3}{4}$ mile west of the Village.

Our new DA will be addressing those people who have failing septic in the county. Those that have received the fines of \$225 and not addressed the issues will now be followed up on.
