Treasurer's Report:

As of 11/30/21 - \$106,985.67 in checking, \$178,145.06 in one Money Market and \$59,556.82 in another Money Market.

Edith Lauscher stated there have been no inquiries.

New Business:

Winter roads will be addressed with sand first then salt if necessary. The five main roads that will be addressed first for plowing are: Valley Road, River Road, Luxemburg Road, Rendezvous Road and Mountain View Dairy.

We will pay the 2022 Luxemburg Fire/Rescue dues of \$80,681.42 this month. ARPA funding uses are continuing to be reviewed as more legislation is made known.

The WTA meeting for Board of Review Certification will be held Friday, February 11, 2022 in Kimberly.

The Luxemburg Fire Dept., Fire Truck #901 has a leaking valve. It will cost \$5,500 to replace the valve and another \$1,250 for plumbing.

SAS employees will be parking along the chain link fence as the remodeling is being done to their shop.

Received notification of the 2022 General Transportation Aid in the amount of \$154,506.63.
