Treasurer's Report:

As of 4/30/23 - \$88,401.98 in checking, \$181,005.56 in one Money Market and \$77,505.23 in another Money Market. We have collected money for delinquent dog licenses and have about 4 still outstanding. All personal property taxes have been collected.

Zoning Report:

Edith Lauscher reported a building permit was issued to Daniel Vandenhouten for building a shed. Lisa Christoph has not returned her paperwork and Edith will also be following up on the Adam Zehren build.

Luxemburg Sportsman and Rendezvous of Luxemburg have submitted paperwork for their liquor license renewals. Notice will be in the paper next week.

Burning of garbage, grass, buildings, etc, is prohibited in the town of Luxemburg without a permit. We still have residents burning without getting a permit. Because of this the Sheriff's Department is requesting that towns issue a code to anyone requesting a burn. You need to call the Chair (920.536.0385) 24 hours ahead of time. She will give you a key phrase/word. When you call dispatch, they will ask you for this code. If you do not have the code, they will inform you that you need to call the Town Chair. Remember if you burn without a burning permit, you will be responsible for any fire calls where the fire department is sent out to you.

Reminder: Every person is required by law to destroy all of the following noxious weeds growing on land in the Town of Luxemburg, Kewaunee County, owned, operated or controlled by that person: Canada Thistle, Creeping Jenny, Garlic Mustard, Autumn Olive, Phragmites, Buckthorn and Wild Parsnip.
