June 2021 Town of Luxemburg Meeting

Meeting called to order by the Town Chairman Linda Jonet at 7:00 PM

Order of Business:

Approval of the May 2021 meeting and the June 10th Road Work Bid meeting minutes less the \$4,400 bid for Lowell Road - motion made by Leonard Wachal, 2nd by Ken Dart to approve. 2 ayes, 0 naves. Motion carried

Treasurer's report: \$131,185.39 in checking and \$177,614.26 in the Money Market
Outstanding personal property tax is still required from Praxair Distribution Inc of \$20.14.

Zoning Report:

Paul Wery hasn't gotten his septic permits or gotten back to Edith yet.

Scott Weidner needs a new building permit as the old one is over a year ago and will contact her.

Old Business:

Rendezvous of Luxemburg (7 bartenders) and Sportsman Club (10 bartenders) applied for renewal of a tavern license. Motion made by Leonard Wachal, 2nd by Ken Dart to approve. 2 ayes, 0 naves. Motion carried.

Casco Sand and Gravel and Phillips Trucking applied for renewal of a mining permit. Motion made by Ken Dart, 2nd by Leonard Wachal to approve. 2 ayes, 0 naves. Motion carried.

Summer Road work noted is Rockledge Road Shouldering, Valley Road Shouldering, Valley Road Bridge, Northbrook @ Cty Line, River Road Culvert, Walhain Road 54 North, Lowell Road between Northbrook and River Road, Nachurs Way. The last 3 came in at \$106,690 from Scott Construction.

Village paperwork was signed for Lee and Cindy Johnson to annex their home (½ acre lot on Church Road) to the Village. The tree farm will remain with the Town.

New Business:

Lynn Aude was issued a fireworks permit.

Grass cutting has been completed.

Tractor has been repaired with new hoses in the boom costing \$2,508.77.

Complaints have been received by the Town Board regarding the visibility at the intersection of Luxemburg & Rendezvous Road. Jared Massey has informed Leonard Wachal that he will take care of getting the tree limbs cut.

Jim Reckelberg asked to have a school bus sign taken down on River Road. Linda Jonet will look into this.

Burning Permits - We had 7 controlled burns and only notified of 4. People need to notify Linda Jonet of the burning and when done. Otherwise they will need to pay the fire department directly should they be called.

The Town will be getting \$154,490.79 from the American Rescue Plan Act (ARPA). We have 1,476 people in our township.
