Treasurer's Report:

As of 3/31/23 - \$63,387.76 in checking, \$181,005.56 in one Money Market and \$77,505.23 in another Money Market.

Zoning Report:

Edith Lauscher reported the following building permits were issued for MR Meats, Carpentry Unlimited (Brad Zellner) and Legacy Livestock LLC. The decision of the April 17<sup>th</sup> rezoning for Salentine/Mleziva was denied by the Planning Commission and the Town Board. Connie Mleziva questioned the denied request with public comments and discussion held. The request remained denied.

New Business:

Josh Salentine is having Breakfast on the Farm on June 18<sup>th</sup> and requested to have a driveway on Valley Road for 2 car lengths which will be removed by July 1<sup>st</sup>. Also wanted from 7am-11am traffic on Valley Road be southbound. The board approved this.

Brian Paplham of Scott Construction has agreed to fix Walhain Road from Hwy 54 to Church Road applying a single hot oil seal using 1/8 black stone chip sealing for \$32,690 and B/K Line Road from Luxemburg Rd to the south 2640 ft applying a single hot oil seal using white stone for \$18,215 and culvert patching.

The Planning Committee received their new terms: Jim Salentine – 2 years, John Haen – 3 years, Gene Seidl – 2 years, Greg Ronsman – 3 years, Paul Rank – 3 years, and Jerry Meisler – 1 year

On April 12, 2023 Dan Rank requested in writing to come back to the Town of Luxemburg. Linda Jonet read his request and the Town Board approved.

Winter maintenance for the last 3 years: 2021 = \$69,958.54, 2022 = \$97,836.76 and 2023 = \$101, 651 which was \$4k over budget
